Pharma in Goa: An Overview

ABSTRACT

Pharmacy is the health profession is charged with ensuring the safe and effective use of pharmaceutical drugs. Goa has also emerged as a manufacturing base for several leading companies. The pharmaceutical industry in Goa has emerged as a major component in the industrial development of the State. It has a few educational institutions imparting courses in Pharmacy. Goa is one of the fastest growing states in the Country and nearly71pharma companies are housed in the State. Goa is a vibrant pharmaceutical manufacturing hub fortified with sound knowledge based institutions and skilled human resource available in the state; it provides innovative, quality and affordable health care solution to masses. And activities are generating more employment, industrialization and elevating the quality of life in Goa In this short review author provides some of the glimpses of the pharmacy profession in Goa.

1. INTRODUCTION

Goa is located in the western region of India. The state shares its border with the Arabian Sea to the west, Maharashtra to the north and Karnataka to the south and the east. It is one of the fastest-growing states in the country. Goa has a coastline of about 104 kms and inland waterways of about 250 km. The coast is full of creeks and estuaries formed by rivers.

Goa has a strong presence in mining, tourism and pharmaceuticals sectors. Mining (iron ore and manganese), pharmaceuticals, iron and steel industries are present in North Goa while mining and shipbuilding industries are present in South Goa. Tourism is the largest segment in the services sector. Goa is traditionally known as a tourist paradise for its natural scenery, beautiful beaches and cultural diversity. In 2014, the state attracted 4.05 million tourists, including 0.51 million foreign visitors.

Goa has also emerged as a manufacturing base for several leading companies in areas such as fertilisers, tyres and tubes, cement, electrical machinery, fish-net making machines, automatic washing machines, printed circuit boards, pharmaceuticals and pharmaceutical machinery. Cashew processing has also been a traditional industry in the state.

As of 2014-15, the state had 7,967 micro, small and medium enterprises (MSMEs) and 192 large scale industries.

- The state is in the process of developing the logistics sector by forming a special logistics group and constructing several bridges to address the existing deficiency with regard to logistics and warehousing.
- Goa Pharmaceutical Manufacturers' Association (GPMA) is a registered body formed with the objective of uniting the pharmaceutical manufacturers in Goa.
- The Government of Goa has introduced the new Goa Investment Policy 2014 in order to boost investor confidence and attract new industries to Goa.
- The state Government is also working on a new tourism policy with a vision of overall tourism development and to engage with private players to invest and develop infrastructure in the state.

2. PHARMACEUTICAL INDUSTRY IN GOA:

The genesis of the pharmaceutical industry in Goa, after liberation, commenced in the late 1960's with the establishment of pharmaceutical companies such as Cater Wallace, Kare Laboratories Private Limited, Geno Pharmaceuticals Limited, Centaur Pharmaceuticals Limited and Merit Pharmaceuticals Limited. The growth of the pharmaceutical industry was very slow in Goa, postliberation because of a number of reasons such as lack of appropriate infrastructure, inadequate availability of industrial land, power and water supply, shortage of skilled labour, wants of technical manpower and above all entrepreneurship of the right mettle. The major growth in the pharmaceutical sector in Goa started in late 1990's (Kare, 2004). The five years tax holiday for Goa announced in the Union budget in the year 1993, which was further extended to the period up to 31-3-2004, as per section 80-IB (4) of the Income Tax Act, gave further impetus to the development of the pharmaceutical sector in Goa. From 1995 onwards an all-round development took place and today pharmaceutical industries have over 120 registered units employing approximately 20,000 people directly, besides an additional 2000 to 3000 are employed in the marketing of pharmaceutical products (Salgaocar, 1992). A number of ancillary units such as packaging, printing and allied industries have started to meet the requirements of the pharmaceutical industry, where the employment is also quite large. The pharmaceutical industry in Goa has emerged as a major component in the industrial development of the State (Kare, 2004). With the conducive environment in the State a large number of pharmaceutical units have found Goa to be an attractive destination for investment. Several small, medium, large and joint ventures in pharmaceuticals have come to be established in Goa, during the last 30 years or so creating the scenario, as it exists today. Goa has emerged as a hub for pharmaceutical companies. It is the sunrise industry of the State. Goa has been able to attract big Indian and Multinational pharmaceutical companies between the decade of 1993-2003 (Salgaocar, 1992). These include big names like Glenmark, Zydus Cadila Health Care Limited, Unichem, Lupin, Ratio Pharma, Watson, Ranbaxy, Aventis, Cipla, Wyeth Limited, Abbott India Pharmaceuticals Limited. Most of the pharmaceutical units in Goa manufacture basically pharmaceutical formulations in various dosage forms like tablets, liquid orals, small as well as large volume parenterials, dry powder parentheticals, capsules, ointments. The Government of Goa is not encouraging the manufacture of bulk drugs because it is feared that these are polluting industries. The turnover of the pharmaceutical industry in Goa is Rs. 5000/- crores per annum. The exports of this industry are

Rs. 3000/- crores. The magnitude of the industry has catalyzed a number of ancillary and service units in and around Goa. This eases the availability of most types of packaging material, consumables and allied services necessary for the smooth running of the industry. Simultaneously, traders trading in a variety of raw materials, chemicals, packaging material and other consumables, which contribute to the productivity and progress of the industry, have set up shop in Goa. All these activities are generating more employment, industrialization and elevating the quality of life in Goa.

3. History of FDA

The Directorate of Food and Drugs Administration, Government of Goa was established in November' 1991 with its office functioning from the building premises at Campal, Panaji – Goa. Thereafter the office premises was shifted and functioned from the Old Goa Medical Complex at Panaji – Goa; until October 2003 and thereafter the Directorate functioned from the Old IPHB Complex at Altinho, Panaji – Goa until February 2014.

Presently, the Directorate now functions from the Directorate of Food and Drug Administration, 'Dhanwantari', Opposite Shrine of the Holy Cross, Bambolim Goa 403202. Prior to the establishment of an independent Food and Drugs Administration, the Directorate was functioning as an office of the Drugs Controller as one of the various units under the Directorate of Health Services at Campal and was entrusted to handle all food and drugs related legislation. The Directorate functions with its one wing involved in the administration and drugs/food activities through its office situated at Altinho; whilst it's Food and Drugs Laboratory functions from its independent building located at Bambolim.

Food and Drugs Organization

The overall quality control of the drugs and food manufactured, distributed and sold in the State of Goa is exercised by the Directorate of food and Drugs Administration as part of the Health Care Organization under the Department of Public Health in the State Government.

The Directorate of Food and Drugs Administration mainly discharges the statutory functions involved in the implementation of Drugs and Cosmetics Act, 1940 & Rules there under; Prevention of Food Adulteration Act, 1954 & Rules there under. Apart from the duties involved

in the enforcement of these two main Acts and Rules, other Acts, Rules, and Orders towards which Administration has the responsibilities are as under:

- 1) The Drugs and Magic Remedies (Objectionable Advertisement) Act, 1954.
- 2) The Narcotic Drugs and Psychotropic Substances Act, 1985.
- 3) Goa Narcotic Drugs & Psychotropic Substances Rules, 1987.
- 4) The Drugs (Prices Control) Order, 1987 / 1995.
- 5) The Pharmacy Act, 1948.
- 6) Goa Prevention of Food Adulteration Rules, 1982.

Drugs

- Licensing of drug manufacturing and sales establishments.
- Licensing of drug approved testing laboratories.
- Approval of drug formulations for manufacture.
- Licensing of drug manufacturing and sales establishments.
- Licensing of drug approved testing laboratories.
- Approval of drug formulations for manufacture.
- Grant of certificates WHO-GMP COPP, Validity, Performances, etc.
- Monitoring of quality of Drugs & Cosmetics, manufactured in the State and those marketed in the state.
- Detection of any manufacture and sale of drugs without licences.
- Verifying the compliances of the conditions of licences.
- Verifying sale of drugs on prescription.
- Verifying the availability of Registered Pharmacists at Retailers.
- Issue of permits for the sale and consumption of narcotics medicinal drugs.
- Investigation and prosecution in respect of contravention of legal provisions.
- Administrative actions.
- Pre- and post- licensing inspection.
- Recall of sub-standard drugs.
- Verifying availability of any banned drugs, spurious drugs, etc.
- Screening of any objectionable advertisements relating to drugs.

Cosmetics

- Licensing of cosmetics manufactured in the State;
- Approval for cosmetics formulations;
- Monitoring the quality of cosmetics manufactured in the State as well as those sold in the State;
- Verifying the compliances of the conditions of licences;
- Pre-and post-inspections;
- Investigation and prosecution in respect of contravention of legal provisions.
- Administrative actions.

Food

- Licensing of all food establishments dealing in food articles;
- Licensing of all hotels, restaurants, eating houses, fast food, street food vendors, etc;
- Monitoring the quality of food being manufactured in the State as well as those marketed in the State;
- Verifying the compliances of food articles to the law;
- Enforcing the ban on tobacco-related food articles;
- Conducting awareness programs to educate the masses, vendors as well as consumers;
- Investigation and prosecution in respect of contravention of legal provisions relating to adulterated food articles or dealing in prohibited injurious food articles.

Our Vision, Mission, and Values

To strive for pharmaceutical excellence and health by ensuring the availability of safe, effective and quality food and drugs to the public and our endeavor to continue with the time-tested tradition of sustaining Goa Food and Drugs Administration as one of the best FDA in the Country and pool into all sincere efforts to place FDA – Goa on the global map as one of the best regulatory institution.

Role of FDA

The Directorate of Food and Drugs Administration is entrusted with the task of implementing and enforcing all the Food and Drugs related legislation, which includes controlling the quality of food articles and drugs, manufactured and sold within the State as well as manufactured outside the State but sold in the State.

The Directorate through its independent Food and Drugs Testing Laboratory is entrusted with the responsibilities in analysis of various food and drugs, samples drawn by the Food Inspectors and Drugs Inspectors respectively, liquor samples, referred by the Excise Department, Narcotic samples referred by the Police and Customs Department as well as analysis of imported food articles referred by the Mormagoa Port Authorities.

The Directorate also regulates the prohibition on the sale, manufacture and stocking of injurious food article viz food article containing tobacco under the Goa Public Health (Amendment) Act 2005, which includes Gutka etc.

Laboratory

The Directorate has its independent Food & Drugs Laboratory for testing of food and rugs samples at Bambolim, which was constructed under the Capacity Building Project of the Ministry of Health & Family Welfare, Government of India assisted by the World Bank; the said independent laboratory was constructed and commissioned for operation since March 2007.

The building comprises of the ground floor catering to the food analysis, whilst the first floor caters for the drugs analysis; Both the Food & drugs laboratory section have been adequately equipped with all the modern essential and sophisticated equipments and instruments necessary for testing of food and drugs samples.

The laboratory consists of a separate independent staff of Senior Scientific Officer, Junior Scientific Officer, Chemist and Assistant Chemists, laboratory Attendant and Laboratory Technicians separately for the food and drugs sections.

The laboratory conducts analysis of food and drugs samples referred by the Food Inspectors as well as Drugs Inspectors under the respective food and Drugs Law.. In addition imported food

articles samples are referred by the Port Health Authorities, liquor samples by the State Excise Department and the narcotic samples by the Police and Customs department. On an average, annually 600 food samples and 800 drugs samples are analyzed by the Laboratory.

Goa State Pharmacy Council, Panaji is a state authority under the control of State Government. Goa State Pharmacy Council is situated in Panaji of Goa state (Province) in India.


