HOW THE HERBS ARE USED IN MAKING A COSMETIC PRODUCTS:

In earlier times herbs are used as medicine and for the beautification purposes. They were used in a dried form or in a fresh form. But nowadays their extracts, tinctures rather than that of herb itself is used.

- **1. Infusion:** Infusion is a process of extracting the chemical compounds or flavors from the plant material. Solvent used in this process are water, oil or alcohol etc. ^[18].
- **2. Decoctions:** Decoction is a method of extraction. Plant material such as stem and roots boiled first, by this all the chemical of the material get dissolved. This process involves mashing the plant material by complete dissolution and then boiling it in water to extract volatile organic compounds and oils etc. ^[19].
- **3. Oil soluble extracts:** Oil soluble extract are prepared by extracting herbs with petroleum ether. The herbs soak in water overnight. Water mixture is placed in a vessel containing oil and heated till the water got evaporates. Keep the oil for cooling and then filter it. In this way oil soluble principle of herb goes into oil ^[20].
